1. Ethol Cadeirydd

PENDERFYNWYD YN UNFRYDOL i ethol y Cynghorydd R Owens yn Gadeirydd am y flwyddyn sydd i ddod.

Gan gymryd y Gadair, diolchodd y Cynghorydd Owens i'r Aelodau am eu hymddiriedaeth ynddo. Dywedodd bod y Pwyllgor y llynedd wedi ymdrin ag amrywiaeth o geisiadau cynllunio mewn modd ymroddgar a phroffesiynol, gan helpu i gynnal a gwella prydferthwch naturiol y Parc Cenedlaethol. 1. Election of Chair

It was **UNANIMOUSLY RESOLVED** that Councillor R Owens be elected Chair for the ensuing year.

Taking the Chair, Councillor Owens thanked the Members for their confidence in him. He noted that in the previous year the Committee had dealt with a variety of planning applications in a diligent and professional manner, helping to maintain and enhance the natural beauty of the National Park. However this would not have been possible without the excellent planning team lead by the Director of Planning and Park Direction, Nicola Gandy, and the help and support of the Democratic Services Team. Adding a personal note of thanks, Councillor Owens expressed his gratitude for the excellent support he received from staff at the National Park and he hoped that this would encourage other disabled people to take up similar public office roles. He also wished to thank Councillor M Williams, who had served as Deputy Chair for a number of years, for his invaluable support.

2. Election of Deputy Chair

The Chair explained that as there were 2 nominations for the Deputy Chair – Dr M Havard and Councillor P Kidney - it was necessary to conduct a secret ballot. This would be undertaken in accordance with Amended Standing Order 5 as agreed at the Meeting of the National Park Authority in May, whereby Members were asked to email, text or phone their vote through to the Administration and Democratic Services Manager.

It was **RESOLVED** that Dr M Havard be elected Deputy Chair for the ensuing year.



3. Apologies
